

SIMORGH CUP 2025 – VOLLEYBALL GAME WAIVER AND RELEASE OF LIABILITY

IMPORTANT – PLEASE READ CAREFULLY

By signing this document, you acknowledge and agree to the following terms and conditions regarding your participation in the Simorgh Cup Volleyball Tournament (April 12, 2025). This waiver is intended to release the volunteer organizers, sponsors, volunteers, and venue operators from any liability in the event of injury, illness, or other incidents that may occur during or in connection with the event. This event is entirely organized and run by volunteers. No individual involved in planning, coordinating, or managing the Simorgh Cup receives any form of payment or financial benefit. All fees collected are solely used to cover direct tournament expenses such as venue rental, registration, snacks, medals, and merchandise. By participating in this event, you acknowledge that there are no professional organizers involved, and all individuals assisting are doing so voluntarily.

1. Acknowledgment of Risk

I, the undersigned, fully understand and acknowledge that participation in a volleyball game, whether recreational or competitive, involves inherent risks, including but not limited to:

- Physical injuries (e.g., sprains, strains, broken bones, head injuries)
- Collisions with other participants, equipment, or the playing surface
- Overexertion, dehydration, and heat exhaustion
- Equipment malfunction or facility hazards (e.g., uneven flooring, loose cables, poor lighting)
- Unforeseen accidents or incidents during play or while on the premises
- COVID-19 or other communicable disease exposure
- Transportation-related risks to and from the event

I understand that these risks can result in serious injury, permanent disability, or death, and that not all risks can be foreseen or eliminated.

2. Voluntary Participation and Assumption of Risk

I certify that I am voluntarily participating in this volleyball event and that I am physically fit to engage in such activity. I assume full responsibility for any and all risks, whether known or unknown to me at the time of participation.

3. Waiver and Release of Liability

In consideration for being allowed to participate in the Simorgh Cup, I hereby waive, release, and forever discharge the event organizers, referees, volunteers, facility operators, sponsors, and any affiliated individuals or entities from any and all liability, claims, demands, causes of action, or expenses arising out of or related to any injury, illness, loss, theft, or damage I may suffer or cause, whether arising from the negligence of the released parties or otherwise.

4. Medical Treatment and Emergency Care

I authorize the organizers to seek emergency medical care on my behalf if deemed necessary and understand that I am solely responsible for any resulting costs. I acknowledge that no medical personnel may be present at the event and that I participate at my own risk.

5. Code of Conduct

I agree to conduct myself respectfully and responsibly during the event and follow all rules and instructions provided by the organizers and referees. I understand that violation of conduct rules may result in my disqualification or removal from the tournament without refund or liability.

6. Food and Allergy Disclaimer

Snacks and refreshments may be made available during the event. By choosing to consume any food or beverage provided, you acknowledge that you are responsible for ensuring your own safety with respect to allergies or dietary restrictions. The volunteers and coordinators are not liable for any allergic reactions, food intolerances, or health issues that may arise from the consumption of provided items.

7. Waiver for Spectators, Volunteers, and Minors

This waiver applies not only to players, but also to any spectators, guests, family members, volunteers, or minors present at the event. All individuals on the premises are considered participants in the context of liability and are therefore bound by the same waiver terms. Parents or legal guardians must sign on behalf of minors under the age of 18. By attending this event, all attendees agree to waive any right to hold volunteers or organizers liable for incidents, injuries, or losses occurring during the event.

8. Media Release (Optional)

I consent (or do not consent by crossing this section) to the use of my name, image, and likeness in photographs or videos taken during the event for promotional, reporting, or social media purposes by the organizers.

9. Final Acknowledgment

I acknowledge that I have read this document thoroughly and understand its contents. I understand that by signing this waiver, I am giving up certain legal rights, including the right to sue. I sign this voluntarily and without inducement.
